The KUTS project aims to transform Kuching into a dynamic and competitive city with the provision of green and efficient public transportation services for the Greater Kuching area with the introduction of the Autonomous Rapid Transit (ART). The ART will be the backbone of the public road transport in Kuching city, and it will be supported by the feeder bus network in providing the first mile and last mile connectivity. KUTS will alleviate traffic congestion and improve urban connectivity, therefore creating more economic opportunities and enabling trade as well as facilitating access to broader markets and services.

- Tenderers may participate either as (i) Single Entity or (ii) Joint Venture (JV) [in case of JV, JV shall not have more than three (3) partners. Tenderers shall possess relevant experience and proven track record of having successfully completed Works of similar nature and meet the Requirements by submitting the proof of registration, experience and compliance to the following requirements:
  - Local Malaysian Contractors / Companies registered with:
    - Companies Commission of Malaysia (SSM) and/or Registrar of Business (ROB); and/or
    - Sarawak State Financial Secretary Office i.e., Unit Pendaftaran Kontraktor dan Juruperunding (UPKJ) under Registration Category: Supply & Services, Class A, Head X; and/or
    - Ministry of Finance, Malaysia; registered under Code 21;
  - Foreign Contractors / Companies incorporated in Malaysia with Foreign Shareholding – to provide Certified True Copy of the relevant Company Secretarial Documents; or
  - Foreign Contractors / Companies registered under SSM – to provide Certified True Copy of the relevant Company Secretarial Documents;
  - Foreign Contractors / Companies – to provide Certified True Copy of Company's Incorporation Secretarial Documents and Certificate certified by authority in the country of origin.
  - Average Annual Turnover (only from contract receipts) for the last three (3) financial years (2020, 2021 and 2022) shall not less than Ringgit Malaysia Two Million (RM2,000,000.00).
  - Minimum paid-up capital (based on the latest financial year audited report):
    - For Single entity: Ringgit Malaysia One Million Only (RM1,000,000.00);
    - For Joint Venture (JV): Ringgit Malaysia Two Million Only (RM2,000,000.00), for Lead Partner Min. RM1,000,000.00 and combined for all partners RM2,000,000.00 based on the latest financial year.
  - Average net profit for the last three (3) financial years (2020, 2021 and 2022) shall be positive and for JV minimum two (2) partners MUST be positive including the Lead Partner.
  - In addition, the Tenderer must have experience in completing at least one (1) Bus Integrated System (BIS) or similar intelligent transport system project delivery within the last ten (10) years (2012-2022) that consist of the following systems/subsystems:
    - Planning, Scheduling & Dispatching System (PSDS);
    - Fleet Tracking System (FTS); and
    - Automatic Fare Collection System (AFC).
 And any of the following:
    - Computerised Maintenance Management System (CMMS); and/or
    - Information Technology System (ITS); and/or
    - Centralised Reporting System (CRS)
  - The proposed Project Manager must have at least ten (10) years of related experience in Bus Integrated System (BIS) or in a similar intelligent transport system.

**NOTE:**

In the event the Tenderer is a JV, then the above requirements may be fulfilled by the partners jointly and they shall be required to submit related supporting documents for each of the items above as evidence/proof.
