    - Ministry of Finance, Malaysia under Code 330000 and/or 340000 and/or Pejabat Setiausaha Kewangan Negeri Sarawak (UPKJ).
    - Board of Engineers Malaysia (BEM) under the Engineering Consultant Practice (ECP).
    - Companies Commission of Malaysia (SSM) and/or Registrar of Businesses (ROB).
  - Minimum combined paid-up capital in Ringgit Malaysia: One Million (RM1 Million) (based on the latest financial year).
  - Average net profit of the last three (3) years must be positive.
  - Minimum qualification requirements:
    - Must be established for more than ten (10) years in Infrastructure Engineering Design Consultancy and Supervision Services;
    - The Project Director must have at least fifteen (15) years of experience in managing projects that include design and supervision in Highway/Road and Railway projects;
    - Minimum ten (10) years' experience as Consultant in Infrastructure Engineering Design and Supervision in similar projects that include either any one of the Roads/Highways, Automated Rapid Transit (ART), Bus Rapid Transit (BRT), Railway or other Urban Transport related projects;
    - Completed minimum two (2) similar projects as stated above in the last ten (10) years (i.e between year 2011-2020); and
    - One of the completed projects above shall have a project value of not less than RM500 Million.
